## AIRSTREAM WARRANTY



For the lifetime of the Registered Warranty Holder, or so long as he continues as the original owner of the Airstream Travel Trailer, Airstream warrants the metal shell, frame, axle and axle assembly to and including spindle (excluding shock absorbers) to be free from defects in material and workmanship; all other component parts, including shock absorbers (excluding tires and batteries) are likewise warranted for a period of two years from the date of purchase. Any warranty defects will be corrected without cost upon return of the trailer, or defective part, to any Airstream factory or authorized Airstream service center.

*This warranty is in lieu of all other warranties of merchantability or fitness expressed or implied, there being no warranties which extend beyond the description on the face hereof and expressly excludes conditions resulting from normal wear, accident, abuse, exposure or overload.*

As soon as the factory has received your signed check-out sheet, your Airstream warranty will go into effect . . . a formal warranty will be issued to you . . . and an owner's identification card will be sent you so that you may receive warranty work without charge from Airstream Certified Service Center dealers. When you receive your formal warranty remove and destroy this facsimile, then put formal warranty inside front cover of this manual.

**CAUTION:** You must register within 30 days of purchase of your Airstream to be eligible for the Airstream warranty.

**Please note that your warranty will not be in effect until it is registered, and that Airstream Factory Authorized Certified Service Centers are not authorized to provide service under the Lifetime Warranty unless your I.D. card or registered warranty can be produced at the time the service is performed.** If and when the occasion arises that you require service on your trailer, we suggest that you contact your dealer. If the service is minor, or simply involves an adjustment, he will perform the service. Should you require service on one of the appliances, he may suggest you contact one of the service and repair depots provided for each appliance. These depots will provide service under their respective warranties. For major service under your Airstream Warranty, we have established a nationwide network of Factory Authorized Certified Centers, staffed with factory-trained service specialists. For prompt service simply present your Airstream Lifetime Warranty or I.D. card to any of the Factory Authorized Certified Service Centers listed

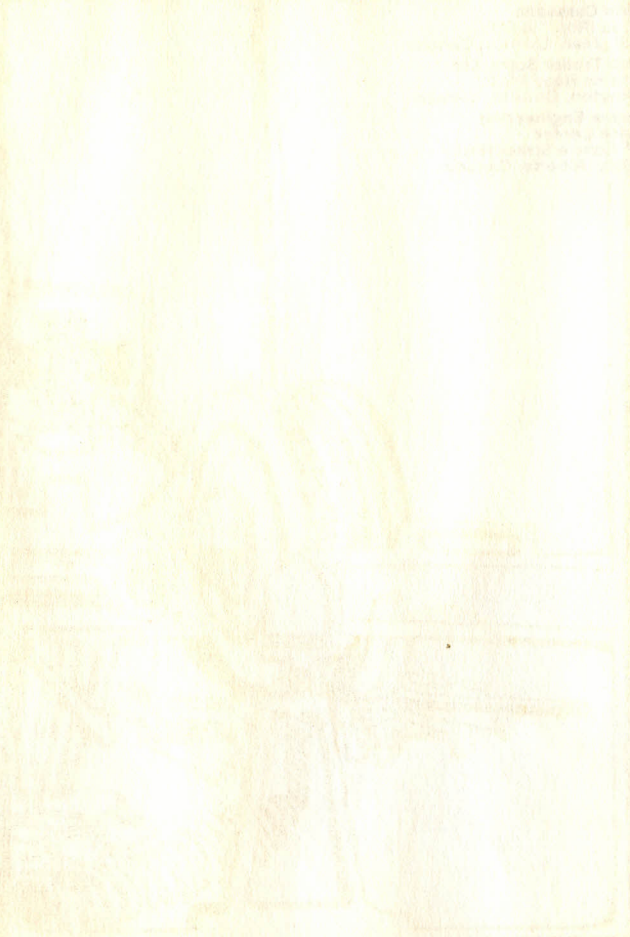
